After properly filing separate renewal certification applications as natural gas brokers and aggregators, and electric power brokers and aggregators, I notice several errors in how they were processed on the PUCO docketing website. I respectfully ask that you please make the following corrections:

1. Our 34-page renewal application in case 04-593-GA-AGG was not docketed. (This appears to be an oversight as it was submitted in the same mailer as our motion for protective order and confidential statements. Those documents were docketed but not our renewal application.)
2. The description on our electric renewal application (04-592-EL-AGG) should read "electric power broker and aggregator" not natural gas. Refer to the attached screen shot.
3. The confidentiality sheet for our electric filing should read "Case # 04-592-EL-AGG" instead of the GA reference for gas filings. Refer to the attached screen shot.
