ENTRY

The Commission finds:

- (1) On March 18, 2008, Verizon North Inc. (Verizon) filed a motion for waiver of the requirement, under Rule 4901:1-5-08(B)(5), Ohio Administrative Code (O.A.C.), to clear out-of-service trouble reports within 24 hours. The waiver, as requested, would apply in certain affected Verizon exchanges for the period of March 4, 2008 through March 12, 2008. In the alternative, Verizon requested that a 48-hour grace period, as contemplated by Rule 4901:1-5-08(D), O.A.C., should apply for the same period in its affected exchanges where a customer adjustment would otherwise accrue pursuant to Rule 4901:1-5-08(C), O.A.C.
- (2) On April 30, 2008, Verizon filed a notice by which it seeks to withdraw, in all respects, its March 18, 2008 motion for waiver and request, in the alternative, for a grace period under Rule 4901:1-5-08(D), O.A.C.
- (3) Verizon's request for, as alternative relief, a grace period under Rule 4901:1-5-08(D), O.A.C., was suspended by attorney examiner's entry issued on May 2, 2008.
- (4) Upon review, the Commission finds that Verizon's April 30, 2008 request to withdraw, in all respects, its March 18, 2008 motion for waiver and request, in the alternative, for a grace period under Rule 4901:1-5-08(D), O.A.C., should be granted.
