The Applicant, The Wabash Mutual Telephone Company (“Wabash”), is a not-for-profit company. Wabash hereby proposed to increase its Premise Visit Charge, which is applied when a Wabash representative travels to the customer’s premises to identify service interruption.

The current Premise Visit Charge when the service interruption is attributable to the customer’s equipment is based on time and materials. The first hour is charged at \$40.00; thereafter the charge is \$11.25 per quarter hour. Wabash intends to increase the charge for the first hour to \$52.50, effective July 1, 2008. This increase is due to higher fuel, transportation, and labor expenses.

On June 3, 2008, The Wabash Mutual Telephone Company ("Wabash") will file a Notice of Tariff Filing with the Public Utilities Commission of Ohio. Effective July 1, 2008, Wabash will increase its Premise Visit Charge from \$40.00 to \$52.50 for the first hour. Thereafter, the current charge of \$11.25 per quarter hour remains unchanged. The Premise Visit Charge applies when a Wabash representative travels to the customer's premises for service interruptions attributable to the customer's equipment.

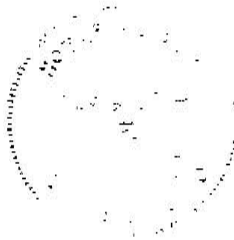
1. I am General Manager of The Wabash Mutual Telephone Company (“Wabash”),
