On behalf of CenturyTel Acquisition LLC ("CTA") and in response to a request by Commission staff, this letter informs the Commission that CTA does not provide service in any exchanges except in those that have customers that, as described in the Application filed in this Case, are being transferred to Onvoy, Inc. d/b/a Onvoy Voice Services ("Onvoy") and Zayo Bandwidth Indiana, LLC ("Zayo-IN"). Since CTA will no longer be providing or offering service in Ohio following the transfer of CTA's Ohio customers to Onvoy and Zayo IN, CTA requests that, as part of this Case, the Commission cancel Certificate No. 90-9073 issued to CTA in Case No. 05-529-TP-ATC on May 17, 2005.<sup>1</sup>
