## **SECTION 1. REGULATIONS**

### **1.1 Customer Rights and Responsibilities**

### **1.3 Returned Check Charge**

A return check charge of \$25.00 will be assessed for checks returned for insufficient funds.

### **1.4 Deposits**

The Company does not collect deposits from its Customers. The prepayment of services which are immediately available to the Customer does not constitute a deposit.


