Dear Ms. Jenkins:

On June 16, 2008, Embarq Local Operating Companies filed its Annual Access Rate filing, under Transmittal No. 52, with the Federal Communications Commission. The revisions made to Tariff F.C.C. No. 1 will become effective July 1, 2008. These revisions are made in compliance with the requirements of the 2008 TRP Notice,¹ and adjust the level of interstate access service rates for the Embarq local operating companies. In addition, Embarq LOC is removing an exogenous cost adjustment originally implemented in the 2007 Annual Access filing that was included pursuant to and consistent with the *Payphone Order*.² This exogenous cost adjustment is removed from the End User Common Line (EUCL) charge.




