**NOTICE OF THE OHIO TELECOM ASSOCIATION  
TO WITHDRAW A PORTION OF ITS JUNE 23, 2008 FILING**

On June 23, 2008, the OHIO TELECOM ASSOCIATION, for and on behalf of its members ("OTA"), filed its Memorandum in Opposition to the Application For Rehearing of The Office of the Ohio Consumers' Counsel, and in Response to the Application For Rehearing of AT&T Ohio ("OTA's Memorandum"). On June 25, 2008, the Office of the Ohio Consumers' Counsel filed a Motion to Strike a Portion of OTA's Memorandum.
