Dear Mr. and Mrs. Cuprys:

I am writing in response to your letter addressed to Governor Strickland. Governor Strickland's office asked that I respond to you on his behalf.

You expressed concern with regard to two issues about the Ohio American Huber Ridge public water system; water quality (brown water) and water rates. You also stated that you are in opposition to any rate increase without improvement in water quality at Huber Ridge.

During 2006 and 2007, at the request of the Ohio Consumers Council (OCC) and the Public a Utilities Commission of Ohio (PUCO), Ohio EPA assisted in an investigation of the water quality in the distribution system (discolored water) at Huber Ridge. Water quality analyses were performed at locations throughout the distribution system where discolored water had been reported. This was in addition to daily routine sampling that continued as required by Ohio EPA.

A hydrant flushing program was implemented as a result of the discoloration issues and this program continues to be performed twice yearly and on an as-needed basis. As a result of this program and other efforts, it was our understanding that discoloration issues had been resolved. Also, since June 2007, the system has met all water quality standards in accordance with Ohio EPA Drinking Water Rules and Regulations.

Ohio EPA was not aware that discolored water issues continue at Huber Ridge. If water discoloration issues are still occurring, then we would very much like to be informed as soon as possible. I ask that you contact Carolyn O'Neal (614-728-3864) at our Central District Office when you experience discolored water, so that we can investigate the probable cause. Also, please contact your water company, the Ohio American Water Company, when the discoloration occurs, so that they are immediately made aware of the problem. The contact telephone number for the water company is given below. Also, both OCC and PUCO have been highly involved with water discoloration problems in the Huber Ridge public water system. OCC and PUCO very much appreciate hearing about situations such as this one,
