I agree with the OCC staff in opposing raising the flat-rate customer charge because such a change in the rate structure would negatively impact my bill. I am trying to conserve energy and the result would be in low use customers (like myself) subsidizing high-use customers. Loading more of Dominion's costs into my fixed charge limits the ability for consumers like me to control my monthly bills by being more energy efficient. With my budget stretched thin (I am a single parent), a higher flat-rate customer charge means I would be paying more than \$17.00 per month regardless of how much natural gas I use!

You and the utilities, a year ago, were urging the consumers to cut back on gas, and electricity.


The consumer's have done so.
