RESALE SERVICE

8. Rate Regulations

- 8.1 Category A services are available to Carriers for resale at the applicable resale discount of the monthly recurring tariff rates:

- A. Services plus GTE Operator Services/GTE Directory Assistance – 12.5%
- B. Services without GTE Operator Services/GTE Directory Assistance – 10.4%

Nonrecurring tariff rates are not subject to any resale discount rate. If the tariff rates change for the Category A services being resold, the rate change also is applicable to the resold services. The Company will provide ten (10) days advance written notice of discounts or promotions. Promotions available for resale must be offered only if the duration of the promotion is greater than 90 days, in total, for a 12 month period. Category B services are not available for resale.

- 8.2 A charge applies for the record change when converting the end user from the Company's account to a Carrier. The rate for this record change is the Service Ordering Charge as found in Section 2 of P.U.C.O. No. 7. The End User Common Line (EUCL) charge, as found in Section 13 of the GTE Telephone Operating companies Tariff FCC No. 1, will continue to apply for each local exchange line resold under this section of the Tariff. All federal rules and regulations associated with that FCC tariff will also apply.
