Sprint Communications Company L.P., Sprint Spectrum L.P., Nextel West Corp., and NPCR, Inc. (collectively "Sprint") hereby provides this letter for the purpose of filing in the above referenced docket that language Sprint will use to notify its customers regarding Ohio Relay service. Sprint is obligated to provide such notice in accord with the terms of the Public Utilities Commission of Ohio's order in the above referenced docket. In advance of filing this letter Sprint worked with Commission staff to determine and agree to notice language acceptable to the Commission. The agreed to language is listed below and will be provided to customers in the form of a bill message at the intervals specified by the Commission. The specific bill message language, and format, Sprint will use to notify its customers regarding Ohio Relay service is as follows:

As the relevant docket has been closed for over five years, Sprint is not serving this mailing on any of the former parties to case. Additionally, Sprint's review of the Commission's April 23, 1998 Entry indicates that the Commission required carriers to file their proposed alternative language in the docket, but it did not require carriers to serve such notices of alternative language on other parties to the case.
