### <u>ENTRY</u>

The Attorney Examiner finds:

- On June 25, 2008, the Commission issued for comment, Staff's proposed revisions to Chapters 4901:1-17 and 4901:1-18, Ohio Administrative Code (O.A.C.), and Rules 4901:1-5-07, 4901:1-10-22, 4901:1-13-11, 4901:1-15-17, 4901:1-21-14, and 4901:1-29-12, O.A.C. Initial comments are due August 11, 2008, and reply comments are due September 12, 2008.
- (2) On July 23, 2008, the Ohio Gas Association (OGA) filed a motion seeking a 30-day extension of the time to file initial and reply comments and responses to question requested by the Commission. OGA states that although its members are in the process of reviewing Staff's proposal and drafting answers to the questions, given the number of significant changes and the work required to prepare the responses to the questions, as well as their complexity, additional time is required. OGA notes that the Staff's proposal includes numerous and significant revisions and additions to the credit and disconnection rules for residential customers and the Percentage of Income Payment Plan.
- (3) The Attorney Examiner determines that OGA has demonstrated good cause to warrant a 30-day extension of the comment and reply comment periods. Accordingly, initial comments shall now be due on September 10, 2008, and reply comments shall be due on October 14, 2008.

#### It is, therefore,

ORDERED, That the OGA's request for an extension of the due date for initial and reply comments is granted. Initial comments are due September 10, 2008, and reply comments are due October 14, 2008. It is, further,
