II. MEMORANDUM IN SUPPORT

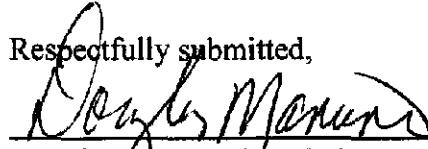

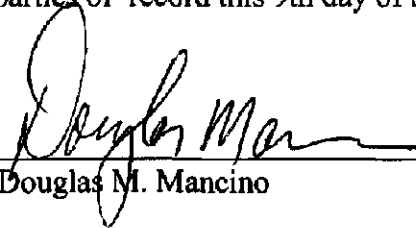
