Dear Ms. Jenkins:

Dialaround Enterprises Inc. (“Dialaround”), by its attorneys, hereby respectfully submits this letter to inform the Public Utilities Commission of Ohio (“Commission”) regarding the status of Dialaround’s detariffing as required by the Commission’s June 6, 2007 Opinion and Order in Case 06-1345-TP-ORD. Dialaround was authorized to provide intrastate resold interexchange services in Case No. 90-6055-CT-TRF. Dialaround provides dial-around (10-10) long distance services in Ohio.

On March 26, 2007, the Commission approved the transfer of substantially all of Dialaround’s assets to STi Prepaid, LLC (“STi Prepaid”) in Case No. 07-319-TP-CIO. In connection with that transaction, Dialaround is in the process of abandoning its operations in Ohio, including the company’s tariff and certificate of public convenience and necessity. Dialaround expects the process to be completed within the next thirty (30) days.

As a provider of casual calling services, Dialaround would be required to request a waiver of the Commission’s detariffing rules with respect to the provisions of its tariff governing casual calling services. Accordingly, Dialaround requests that it be permitted to cancel its tariff pursuant to the Commission’s procedures for abandonment rather than undertake the process of making such a waiver request and moving forward with the detariffing process at this time.
