Re: Authorization to Commence Construction in Previously Excluded Areas

Dear Ms. Weekley:

Based on our review of the information filed by Rockies Express LLC (Rockies Express) on September 17, 2008, I approve your request to commence construction between:

- ☐ The west side of Little Raccoon Creek (MP RR2032 MP 242.9+2.4) and the south side of the field road east of South County Road 360 East MP (RR2032 MP 242.9 + 2.9);
- ☐ The west side of West County Road 525 West (MP 290.6) and the south side of West County Road 150 South (MP 291.4);
- ☐ The west side of Mud Creek (MP 299.6) and the east side of State Road 39 (MP 301.1);

In addition, I approve the start of construction between:

- ☐ MP 233.7 and 234.0, except for the area which is to be fenced and crossed using a travel lane as shown in the Illinois Treatment Plan No. 3; and

- ☐ The western boundary of tract IN-MN-102.NO1 (MP 315.0) and the eastern boundary of tract IN-MN-105.001 (MP 315.5), including a dry crossing of the White River as shown attachment G of the September 17, 2008 filing.

I also approve the use of the following temporary workspaces:

- ☐ A 300-foot by 75-foot area on the north side of the centerline between MPs 251.1 to 251.3 on tract IN-PE-030.000;
- ☐ Two areas (150-foot by 100-foot and 200-foot by 100-foot) on the north side of the centerline between MPs 279.7 to 280.0 on tract IN-PU-217.000;
- ☐ A 200-foot by 100-foot area on the south side of the centerline between MP 301.9 to 302.1 on tract IN-HE-279.000

This approval is in accordance with the environmental conditions of the Commission's May 30, 2008 Order (Order).

This letter does not authorize the construction of other Rockies Express facilities. I remind you that Rockies Express must comply with all applicable remaining terms and conditions of the Order.
