Dear Ms. Jenkins:

AT&T Ohio (which is the name under which The Ohio Bell Telephone Company does business) (the "Company") hereby files revised maps of its Franklin and Miamisburg-West Carrollton exchanges, without application, pursuant to Ohio Administrative Code §4901:1-3-03(F). Reduced copies of the revised maps, size 8 ½" x 11", reflecting the proposed boundary changes, are also attached. Both this letter and the reduced maps are being filed in duplicate pursuant to Ohio Administrative Code §4901:1-3-03(G).

The revised maps reflect the incorporation of portions of AT&T Ohio's Miamisburg-West Carrollton Exchange into the Franklin Exchange. The Company provides the following reason for making this change:

AT&T received a proposed site plan for the Indian Trace Subdivision which will consist of forty-two (42) single family residential units. At the present time the proposed development is located in the Miamisburg-West Carrollton exchange area. This change will increase the area served by the Franklin exchange and decrease the area served by the Miamisburg-West Carrollton exchange.

The affected area is 39,603' from the Miamisburg-West Carrollton central office and 22,652' from the Franklin central office. Facilities are available to this area from the Franklin central office.

The affected area is located east of Jamaica Road and north and east of the intersection of Jamaica Road and Fairview Dr. The changes appear in the northwest corner of the Franklin Exchange map and the southwest corner of the Miamisburg-West Carrollton Exchange map.

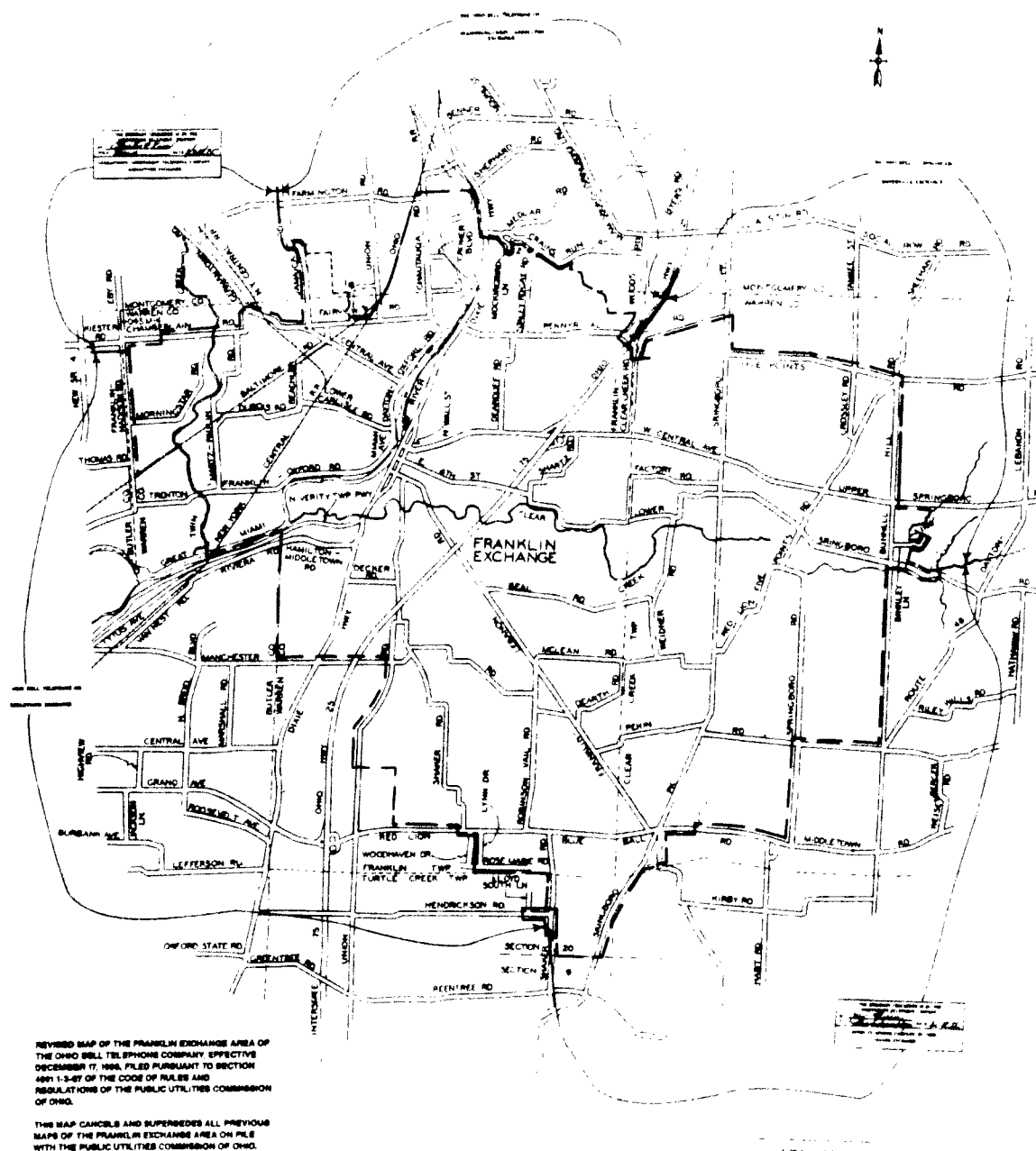

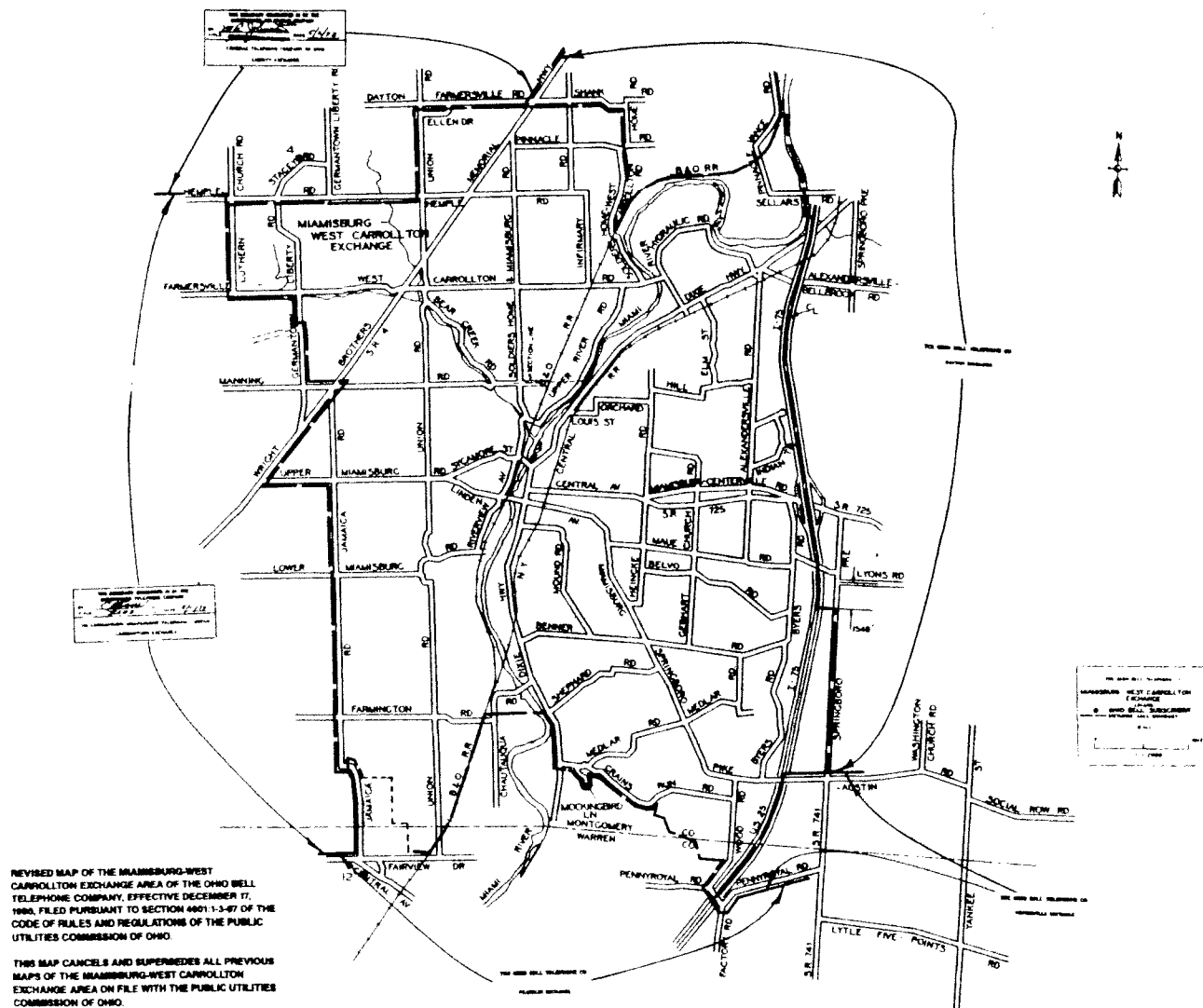
