Revised tariff sheets have been filed with the FCC to amend Verizon Tariff FCC No. 14, Facilities for Interstate Access, in which Verizon North Inc. concurs for intrastate applications.

8. On the next page, you will be shown a table of the filings that have been made for that tariff number starting with the most recent. Click on the part of the filing you want to view under the heading "View PDF". Each filing may have several parts, so look for the transmittal number on each line.

On September 17, 2008, Verizon filed Transmittal No. 952 which modified tariff terms for certain services grandfathered in accordance with the relief received in connection with Verizon's broadband forbearance petition in WC Docket No. 04-440.

Based upon discussions with the Commission staff, and under authority of Special Permission No. 08-019, Verizon is withdrawing the tariff material originally submitted under Transmittal No. 952 and reinstating material currently in effect.

Supporting material as described under Section 61.49 of Commission's rules is not required with this filing.


