
Commissioners:

The Public Utilities Commission of Ohio (PUCO) is concerned about reports we are hearing about the FCC's pending vote on reform measures on universal service and intercarrier compensation.

The Ohio Commission commends the FCC for its impulse to resolve the many outstanding issues of critical importance to telecommunications reform. However, I join my National Association of Regulatory Utility Commissioners (NARUC) colleagues in asking that the FCC take the steps necessary to insure that reform is established in a careful, meaningful way and not rushed to judgment simply to meet a court deadline.

Ohio, like the rest of the country, is feeling the effects of the nation's economic crisis. As Chairman of the Ohio Commission, I am concerned about an FCC order that could negatively impact investment in our most rural, and highest cost markets and, worse still, could cause rates to increase to Ohio citizens and businesses during these tough economic times. Ohio respectfully requests that the FCC delay consideration of such comprehensive reform until the FCC can more fully assimilate the proposal and the potential impact on the industry and consumers.
