On January 9, 2008, AT&T Inc., on behalf of Ameritech, filed a Section 63.71 Application with the F.C.C. for authority, pursuant to Section 214 of The Communications Act of 1934, as Amended, to discontinue ADS throughout its five-state territory, which includes the states of Illinois, Indiana, Michigan, Ohio and Wisconsin. No comments were filed against the 214 Application and, therefore, it was automatically deemed granted on March 28, 2008. Ameritech has no customers for this service.
