MOTION FOR ADMISSION PRO HAC VICE OF CLINTON A. VINCE, WILLIAM D. BOOTH AND EMMA F. HAND

Pursuant to Section 4901-1-08(B) of the Ohio Administrative Code, Ethan E. Rii (#0079299), an attorney licensed to practice law in the State of Ohio in good standing, respectfully petitions the Public Utilities Commission of Ohio ("Commission") to permit Clinton A. Vince, William D. Booth and Emma F. Hand to practice *pro hac vice* before the Commission in the captioned proceeding. Mr. Vince, Mr. Booth and Ms. Hand represent Ormet Primary Aluminum Corporation, an industrial customer of Columbus Southern Power Company and Ohio Power Company.
