### MEMORANDUM IN SUPPORT OF ITS MOTION FOR EXTENSION OF TIME AND REQUEST FOR EXPEDITED RULING

Liberty Power Delaware LLC ("LPD") and Liberty Power Holdings LLC ("LPH") were issued Renewal Certificate Nos. 07-136(1) and 07-137(1) respectively to provide competitive retail electric service for the two-year period commencing February 16, 2007 and ending February 7, 2009. Unfortunately, due to the pendency of an urgent business matter and limited staff resources, LPD and LPH were unable to file their Renewal Applications until January 14, 2009, six days after the January 8, 2009 deadline. As is demonstrated in the Renewal Applications, there have been no material changes in either LPD's or LPH's business practices as defined by Rule 4901:1-24-10 of the Ohio Administrative Code ("OAC").

LPD and LPH respectfully request that the Commission extend Certificate Nos. 07-136(1) and 07-137(1) for six days to February 13, 2009 so that there will be no interruption. LPD and LPH apologize for this delay and assure the Commission that consistent with LPD and LPH's past practices, all reports and certifications required by the Commission will be timely filed in the future.

LPD and LPH also request that an expedited ruling be issued on this motion pursuant to Rule 4901:1-12(C) and (F) of the OAC, considering that their current certificates are due to

expire February 7, 2009. Because LPD and LPH are the only parties to these proceedings, an expedited ruling will not adversely affect the substantive right of any party.

The Commission has the plenary authority to extend the expiration date of LPD's and LPH's certificates for good cause shown. Good cause exists for granting the requested brief extensions. Consequently, Liberty Powery Delaware LLC and Liberty Power Holdings LLC respectfully request a brief extension of the expiration date of their certificates.
