II. MEMORANDUM IN SUPPORT



Mr. Davidow was also lead counsel for Global NAPs in its proceeding before the New York Public Service Commission in response to a complaint brought against Global NAPs addressing issues substantially similar to those raised here, and he continues to represent Global NAPs in that proceeding. Mr. Davidow has also practiced before the state commissions in Pennsylvania, New Jersey and Virginia, and has had professional, informal meetings with Commission staffs in a number of other states.

Yurick respectfully requests the Commission grant the above Motion for Admission Pro Hac Vice.


