(2/24/09) Periodically, I review the testimony & documents filed against PUCO's Case number 08-917-EL-SSO, (Columbus Southern Power), and 08-918-EL-SSO, (Ohio Power), via PUCO's respective web sites. This morning I read the latest entry, (dated 2/20/09, processed 2/23/09), <http://dis.puc.state.oh.us/TiffToPdf/A1001001A09B23B34526A51551.pdf>, included as an attachment "AEPbonusLtr.pdf" with this email, which was filed apparently by a CSP (anonymous) customer. The author indicates that EXECUTIVE GREED, initially believed to be a unique peculiarity of Banking and Financial Institutions, is indeed thriving at American Electric Power, per the claimed February 2009 bonuses distributed to various levels of management. Certainly, even a casual examination of recent AEP Annual and Quarterly Financial Reports would confirm that this Corporation enjoys EXCELLENT FINANCIAL HEALTH and definitely not meriting a massive monetary transfusion sought by this Utility Giant. It is hoped that the OCC, or PUCO itself, will verify the existence of this cavalier approach adopted by its management at a time when it is making its titanic rate increase demands and during a period when the world economy is in freefall toward a Depression. Remember, these BONUSES were apparently distributed only days before the PUCO February 27/28 2009 decision deadline as, what might be termed by some, an act of corporate defiance.
