Pursuant to the February 5, 2009 Entry in these matters, the Ohio Cable Telecommunications Association hereby submits its summary of major issues:

(1) Establishing rates for cable operators to access Duke's poles and conduit necessary for providing service to their customers that are consistent with the rates charged by other utilities in Ohio, the rates charged by Duke's own affiliates in other areas, and the Commission's own rate-setting methodology; and

(2) Establishing other reasonable and non-discriminatory access terms and conditions that ensure a level playing field among communications providers and that do not stifle the delivery of innovative and advanced communications services to Ohio residents.
