OHIO INTEREXCHANGE TOLL SERVICE TARIFF FOR CLOSECALL AMERICA, INC.

This tariff contains the description, regulations, and rates applicable to the furnishing of service and facilities for inter exchange telecommunications services provided by CloseCall America, Inc, with principal offices at 101A Log Canoe Circle, Stevensville, Maryland 21666. This tariff applies to services furnished within Ohio. This tariff is on file with the Public Utility Commission of Ohio, where copies may be inspected during normal business hours.

2.4	Interruption	of Service	(cont'd))

2.4.10 The company does not offer credits for interruptions of usage based service. Unusual circumstances may be handled on a case-by-case basis.

2.7 <u>Taxes</u>
