ENTRY

The Commission finds:

- (1) On December 3, 2008, the Commission issued its Opinion and Order in these proceedings, approving the joint stipulation filed on October 24, 2008, and authorizing Columbia Gas of Ohio (Columbia) to file tariffs to effectuate the low-income, low-use pilot program.
- (2) On February 19, 2009, Columbia filed final tariffs to establish a low-income, low-use pilot program pursuant to the Opinion and Order in these proceedings.
- (3) On February 26, 2009, Columbia filed revised tariffs to replace those filed on February 19, 2009. The replacement tariffs revised the period of time that the pilot program would be in effect. The proposed low-income, low-use tariffs would be, on their face, effective from March 31, 2009, through the last billing unit of March 2013.
- (4) On March 3, 2009, the Office of the Ohio Consumers' Counsel filed a letter to express support for Columbia's tariff filing.

It is, therefore,


ORDERED, That Columbia's tariffs, filed on February 26, 2009, be approved. It is, further,


ORDERED, That a copy of this entry be service upon all parties of record in this case.


