This application is made pursuant to Paragraph 6 of the Stipulation and Recommendation ("Stipulation") approved by the Commission in Case No. 07-1080-GA-AIR ("Rate Case"). As required in the Stipulation, the proposed rate is calculated to produce "a minimum of \$1 million which shall be utilized to continue funding for the low-income weatherization program for customers whose income is between 200% and 300% of poverty level consistent with the program currently provided as a result of the Company's compliance with the Commission's Supplemental Order in Case No. 05-1444-GA-UNC." Stipulation, Paragraph 6 at 6-7. By the terms of the Stipulation, this application is not for an increase in rates. <i>Id.</i> at 7. |

In VEDO's Rate Case, the Commission authorized "... the establishment of an Energy Efficiency Funding Rider ("EEFR"), initially set at \$0.00, applicable to Rate Schedules 310, 315, 320, and 325." Stipulation at 6. The Stipulation required that, "[t]he Company will submit, and the [VEDO DSM] Collaborative will support, an application to establish an EEFR charge to provide a minimum of \$1 million which shall be utilized to continue funding for the low-income weatherization program for customers whose income is between 200% and 300% of poverty level consistent with the program currently provided as a result of the Company's compliance with the Commission's Supplemental Order in Case No. 05-1444-GA-UNC." *Id.* at 6-7. Further, the Stipulation provided that "...any application to establish or adjust the EEFR charge shall be an application to establish a charge and shall not be an application to increase rates." Finally, the Stipulation required that "...the Collaborative will meet and the Company shall file an application to set the EEFR at a level adequate to provide the initial minimum funding of \$1 million by no later than March 31, 2009." *Id.* at 7.

VEDO's DSM Collaborative met on February 5, 2009 and, as shown on the meeting notes attached to this document (Exhibit C-3, Attachment 1), discussed this required EEFR filing. The calculation supporting the rate proposed herein is attached as Exhibit C-3, Attachment 2.
