I am writing to request for Administrative Hearing regarding the Case No. OH1687000549D in which I am directly involved. I was stopped by an officer and was informed that I would receive a verbal warning for the seat belt. The officer could not find anything wrong with the truck that I was driving and told me she would not write me a ticket. Several weeks later I received a seat belt ticket in the mail. I do not feel that I should have received the ticket when I was specifically told that I was receiving a verbal warning. I had the seat belt on but the shoulder strap was behind my back instead of across my chest. The officer that stopped me was a State of Ohio Trooper in uniform, and was very capable of writing me the ticket at that time; I do not find it necessary for you to write me a ticket several weeks later and then give it to me by mail. I look forward to discussing this matter with you in person and will await the date set for the hearing.
