On conference call scheduled Feb 11, 2009 with Wanda Williams we explained that our company insured through Caputo Insurance Agency, Inc. and our records with them prove we do carry a 1,000,000 of public liability (copy of Certificate of Liability Insurance attached for your records and was faxed to your office as ~~respond on monetary~~ assessment)

On Feb. 4, 2009 our company was audited by U.S. Department of Transportation Senior Auditor and I ask him a question regarding FMCSA website that was not reflecting a 1,000,000 liability. He suggested calling State Motor vehicle to see what the problem is.

Associate Chris at NJ Motor Vehicle Ph#: 609-275-2604 checked our records and did research on his end and outcome was: even if our records were updated that we "Cargo carried" which should automatically change Safer website requesting "Insurance Required" a 1,000,000 >> website did not show that... He said that was because our company applied for ICC Number in 2001 as a "General Freight" hauler and ICC was a separate agency at that time and when was taken over by FMCSA agency>> cause of that was that two system not linked, were not in sync...

When we would ask our insurance agent re-file for a 1,000,000, the answer from them was that Insurance company will not issue the 1,000,000 filling until Safer website will be amended and require a 1,000,000

We asked for help again the Douglas Dougherty S/A as we were not able to resolve the Safer Website issue and he gave us fax number to fax request directly to Tura Gatling with Washington FMCSA office where the problem could be corrected and website data was corrected on 2/12/09. (email back up attached for your records)

Therefore we asking your office to remove the monetary assessment as we can not be held liable for FMCSA website lapses.
