With this transmittal, Verizon is revising FCC No. 14 to provide revisions for the 2nd Quarter 2009 Federal Universal Service Fund filing.


The actual filing documents may be viewed on the FCC's Internet website – www.fcc.gov – by doing the following:

6. On the next page, click on "Verizon Telephone Companies."

8. On the next page, you will be shown a table of the filings that have been made for that tariff number starting with the most recent. Click on the part of the filing you want to view under the heading "View PDF". Each filing may have several parts, so look for the transmittal number on each line.

Inc., and Verizon West Virginia Inc. These companies will be referred to as Verizon-East. Verizon East is comprised of the former Bell Atlantic-North (NYNEX) and Bell Atlantic-South. The Verizon Telephone Companies also include Contel of the South Inc., Verizon California Inc., Verizon Florida LLC, Verizon North Inc., Verizon Northwest Inc., Verizon South Inc., Verizon Southwest Inc., and Verizon West Coast Inc. These companies will be referred to as Verizon West. Verizon West is comprised of the former GTE Telephone Operating Companies (GTOC) and GTE System Telephone Companies (GSTC).


This transmittal letter and associated attachments are being filed electronically today via the Commission's Electronic Tariff Filing System (ETFS).
