MONROE COUNTY E – 911 PLAN

On October 22, 2001 the Monroe County Board of Commissioners adopted a resolution to establish a Planning Committee in accordance with the Ohio Revised Code Section 4931.42 and appointed the Planning Committee.

The mission of this committee is to develop a plan for implementation of a county-wide E – 911 system.

The Planning Committee consists of:

MISSION STATEMENT

It is the purpose of the Monroe County 911 system to implement and maintain emergency access points within the county capable of receiving requests for emergency assistance and dispatching the appropriate type and level of aid to address the incident or incidents.

The system commits itself to the highest level of network integrity, technological quality, multi-jurisdictional cooperation and financial accountability.

On October 26, 2001, the Planning Committee met and presented names for the Technical Advisory Committee. The Technical Advisory Committee consists of the following:

BACKGROUND

On June 18, 1985 Governor Celeste signed H.B. 491 as an emergency measure and the bill became effective immediately. The bi-partisan measure was crafted by many state wide organizations working in conjunction with the legislature from a broad base of public support.

Establishment of a procedure whereby local units of government may initiate a local planning process for E - 911 or basic 911.

Provides for the cost sharing of implementing the plan among telephone users, local political subdivisions and telephone companies.

Requires that the plan be approved by a significant majority of political subdivisions prior to implementation.

Monroe County is no stranger to discussions concerning 911. In 1992 a 911 Planning Committee developed an implementation plan. The plan was presented to the electorate and the voters declined to support it. Those familiar with the defeat believe the negative result was the product of a stagnant economy and not enough attention to the voting public directed at the importance of a 911 system.

With the groundwork of implementing communications enhancements which will facilitate coordination, assign appropriate response and avoid duplication, a successful 911 concept is the next logical step.

The result of the intense activity compressed into a few months has been a recommendation to pursue a 911 network for Monroe County as the remaining element in a quality comprehensive emergency response system.

PLANNING PROCESS

The Board of Monroe County Commissioners, in compliance with enacted H.B. 491, established an E-911 Planning Committee on October 22, 2001. This committee, in conjunction with the Technical Advisory Committee is charged with the responsibility of drafting a plan for implementing an E-911 emergency telephone system in Monroe County.

The E-911 Plan Preparation to include:

Number of telephone companies participating

Location and number of Public Safety Answering Points (PSAP'S)

How PSAP'S connect to the network

Operation of the PSAP

Costs and future projections for the E-911 system

PARTICIPATING TELEPHONE COMPANIES

The telephone companies participating will be Ameritech, Alltel and Verizon. Ameritech will be the lead telephone company.

NETWORK COSTS

Ameritech	.12 per month subscriber fee
Verizon	.24 per month subscriber fee
Alltel	.25 per month subscriber fee

PARTICIPATING AREAS

All of Monroe County rural areas

All 18 Townships

All 10 Villages

E- 911 SERVICE

The E – 911 system accelerates the speed of processing a call for public safety services.

An E – 911 operator does not have to search resource manuals or notes to determine the jurisdiction in which a call should be forwarded.

The technology of the E – 911 system will minimize the number of misdirected calls received by the Monroe County E – 911 system. Communications officers will immediately dispatch the proper safety service agency to a disconnected or busy 911 incoming call.

Non-emergency call will be handled in a professional and courteous manner, but not at the cost of legitimate incoming 911 calls. Non-emergency callers will be reminded that 911 is for emergencies only and may be asked to call back on a non-emergency number. Each safety service provider in Monroe County will keep their seven digit telephone numbers in place.

OPERATION, MAINTENANCE AND PSAP LOCATIONS

The Monroe County E – 911 Technical Advisory Committee recommends the central PSAP be located at

Monroe County Sheriff's office or the Woodsfield Fire Station located at 38000 Old Airport Road.

The E – 911 Technical Advisory Committee recommends that an E – 911 Advisory Board be formed to oversee all aspects of the future 911 system.

The Monroe County Board of Commissioners shall determine the funding mechanism to be used throughout the county.

IMPLEMENTATION

Ameritech estimates that the Monroe County E – 911 system can be implemented within the 3 – year limit set forth by the Ohio Revised Code 4931.46

HOW PSAP'S WILL CONNECT

The PSAP'S will connect to the telephone network via 911 voice trunk lines provided by the Ameritech Corporation, who is the host company. All other participating companies will activate and provide trunk facilities to the Ameritech company that will provide central routing.

CELLULAR CALLS

All cellular calls will be directed to the primary PSAP.

In order to comply with Phase I and Phase II of the Federal Communications Commission order on cell integration, modifications may be necessary in the future.

RESOURCES

During the stages of preparation of this plan, the Public Utilities Commission of Ohio has announced the allocation of up to \$400,000.00 for implementing the Monroe County E – 911 system. An estimate of the funds required is to be provided to the PUCO. These funds could pay the cost of the equipment and implementation process.

The United States Department of Agriculture also has low interest loans available to rural areas for possible assistance with the implementation of a 911 system.

Under the most recently enacted sections of the Ohio Revised Code relevant to establishing an operating 911 system, a telephone surcharge of up to .50 cents per

telephone line per month may be charged to support the system. With approximately 8,200 phone lines in Monroe County, the surcharge could be in receipt of around \$49,000.00 annually.

However, funds from the telephone surcharge may only be expended for equipment and maintenance. Funds may not be expended for operational support of a 911 system.

Balance of maintenance and all operational expenses shall be paid from levy proceeds. Such a levy proposed to the Monroe County voters in the 2003 primary election. The within plan is conditioned upon passage of a levy or levies.

TECHNICAL ADVISORY COMMITTEE RECOMMENDATIONS

The following are recommendations of the current E – 911 Technical Advisory Committee to the Planning Committee.

Employment of a Coordinator to oversee any and all correspondence concerning the future E – 911 system, to include the point of contacts of all agencies, organizations and representatives of whom shall participate in the implementation of the 911 system.

The Committee recommends the development of an ongoing E – 911 Advisory Board upon approval of the plan, and to remain in existence as an active support and an advisory body during the development, implementation and operation of the Monroe County E – 911 system.

The Board will be the governing body for future 911 policies, and procedural development of 911 operations. Procedural problems shall be brought through the Coordinator to the Board for resolution. Problems that cannot be resolved will be arbitrated by the Monroe County Commissioners; their decision will be binding and final.

The Committee also recommends that an aggressive effort be put in place to revise and update the current database of the house numbering and addressing system. The recommendation endorses the use of Global Information Systems. The database created from global information is an accelerated tool to assist the 911 system and should be pursued.

A minimum standard of Emergency Medical Dispatcher training will also be a recommendation of the Committee.

The funds made available from PUCO will cover costs of the PSAP equipment and implementation of initial set-up, however the amounts of revenue generated from the telephone surcharges will not be enough to operate the system. The Committee recommends to the Planning Committee and the Board of Commissioners to create a funding mechanism to staff and operate the 911 system consistent with current labor costs and fees.

ESTABLISHMENT OF WIRELESS 9-1-1 SERVICE

MONROE COUNTY WILL IMPLEMENT WIRELESS ENHANCED 9-1-1 UTILIZING CURRENT FCC, PUCO, AND/OR THE OHIO 9-1-1 COUNCIL REQUIREMENTS. ENHANCED WIRELESS SERVICE WILL BE IMPLEMENTED IN TWO (2) PHASES:

PHASE I – ALL WIRELESS SERVICE PROVIDERS WILL BE NOTIFIED AT LEAST SIX (6) MONTHS PRIOR TO THE DESIRED ACTIVATION DATE THAT MONROE COUNTY IS REQUESTING PHASE I WIRELESS ENHANCED 9-1-1 EMERGENCY SERVICE. ALL WIRELESS SERVICE PROVIDERS OPERATING IN THE COUNTY WILL BE IDENTIFIED, THEIR TOWERS LOCATED AND ADDRESSED, AND ROUTING TO THE PROPER PSAP BASED ON TOWER LOCATION AND/OR SECTOR WILL BE ESTABLISHED. WITH PHASE I, THE 9-1-1 PSAP WILL RECEIVE THE WIRELESS CALLERS CALLBACK NUMBER, AND THE TOWER ADDRESS AND/OR SECTOR LOCATION.

PHASE II – ALL WIRELESS SERVICE PROVIDERS WILL BE NOTIFIED AT LEAST SIX (6) MONTHS PRIOR TO THE DESIRED ACTIVATION DATE THAT MONROE COUNTY IS REQUESTING PHASE II WIRELESS ENHANCED 9-1-1 EMERGENCY SERVICE. WITH PHASE II, THE 9-1-1 PSAP WILL RECEIVE THE WIRELESS CALLERS CALLBACK NUMBER, THE TOWER ADDRESS AND/OR SECTOR LOCATION, AND THE CALLER'S LONGITUDE AND LATITUDE COORDINATES (WITH AN ACCURACY LEVEL CONSISTENT WITH FCC REGULATIONS).

WIRELESS ENHANCED 9-1-1 NETWORKING

THE PSAP WILL USE THE TRUNKING INSTALLED FOR ENHANCED 911 FOR THE ROUTING OF WIRELESS CALLS FROM THE HOST LOCAL EXCHANGE COMPANY.

EMERGENCY 9-1-1 CALLS ORIGINATING FROM CELLULAR TELEPHONES WILL BE ROUTED TO THE PRIMARY PSAP ACCORDING TO THE CELLULAR SERVICE PROVIDER TOWER LOCATION.

9-1-1 FUNDING

FUNDING FOR 9-1-1 WILL BE GENERATED BY A MONTHLY SURCHARGE OF THIRTY-TWO CENTS ON WIRELESS TELEPHONE SUBSCRIBERS (EFFECTIVE FROM 8/1/2005 – 12/31/2008), A MONTHLY CHARGE OF FIFTY CENTS OF THE TELEPHONE ACCESS LINES WHICH WILL BE PLACED ON THE NOVEMBER 2006 BALLOT, AND MONEY CONTRIBUTED BY AT&T (BY ORDER OF THE PUBLIC UTILITY COMMISSION OF OHIO, CASE NUMBER 99-0938-TP-COI) IN THE AMOUNT OF \$422,244.10. THE MONROE COUNTY BOARD OF COMMISSIONERS IS THE GOVERNING BODY RESPONSIBLE FOR THE COUNTY WIDE 9-1-1 FUNDS.

THE MONROE COUNTY SHERIFF'S OFFICE WILL COVER THE EXPENSES OF STAFFING, FACILITY MAINTENANCE, UTILITY EXPENSES, INSURANCE, SUPPLIES, AND MISCELLANEOUS OTHER COSTS FOR THE PSAP. IF ADDITIONAL FUNDING SOURCES ARE OBTAINED THIS MAY BE AMENDED.

MONROE COUNTY SHALL PROVIDE COUNTYWIDE WIRELESS ENHANCED 9-1-1 IN ACCORDANCE WITH SECTIONS 4931.40 THROUGH 4931.70 OF THE OHIO REVISED CODE BEGINNING AS SOON AS REASONABLY POSSIBLE AFTER RECEIPT OF THE FIRST DISBURSEMENT FROM THE WIRELESS 9-1-1 GOVERNMENT ASSISTANCE FUND.

FUNDS RECEIVED FROM THE STATE OF OHIO FROM THE WIRELESS 9-1-1 GOVERNMENT ASSISTANCE FUND SHALL BE PLACED IN A SEPARATE FUND AT THE MONROE COUNTY TREASURER'S OFFICE.

THE FUNDS SHALL BE DISBURSED TO THE PSAP BY THE COUNTY TREASURER ON A MONTHLY BASIS.

SUCH FUNDS SHALL BE USED ONLY FOR THE FOLLOWING PURPOSES:


- A. ANY COSTS OF DESIGNING, UPGRADING, PURCHASING, LEASING, PROGRAMMING, INSTALLING, TESTING, OR MAINTAINING THE NECESSARY DATA, HARDWARE, SOFTWARE, AND TRUNKING REQUIRED FOR THE PSAP TO PROVIDE WIRELESS ENHANCED 9-1-1. THESE COSTS MAY BE INCURRED BEFORE, ON, OR AFTER THE EFFECTIVE DATE OF AM. SUB. H.B. 361 AS PASSED BY THE 125TH GENERAL ASSEMBLY IN 2004 AND CONSIST OF SUCH ADDITIONAL COSTS OF THE 9-1-1 SYSTEM OVER AND ABOVE ANY COSTS INCURRED TO PROVIDE WIRELINE 9-1-1. ON OR AFTER THE PROVISION OF TECHNICAL AND OPERATIONAL STANDARDS PURSUANT TO DIVISION (D)(1) OF SECTION 4931.68 OF THE REVISED CODE, A SUBDIVISION SHALL CONSIDER THE STANDARDS BEFORE INCURRING ANY COSTS DESCRIBED IN THIS DIVISION. (SEE OHIO REVISED CODE SECTION 4931.65(A)(1)).
- B. ANY COSTS OF TRAINING THE STAFF OF THE PSAP TO PROVIDE WIRELESS ENHANCED 9-1-1, WHICH COSTS ARE INCURRED BEFORE OR ON OR AFTER THE EFFECTIVE DATE OF AM. SUB. H.B. 361 AS PASSED BY THE 125TH GENERAL ASSEMBLY IN 2004 AND CONSIST OF SUCH ADDITIONAL COSTS OF THE 9-1-1 SYSTEM OVER AND ABOVE ANY COSTS INCURRED TO PROVIDE WIRELINE 9-1-1. (SEE OHIO REVISED CODE SECTION 4931.65(A)(2)).


