HEARING AT 9:00 AM ON APRIL 30, 2009**



Ormet Primary Aluminum Corporation ("Ormet") hereby requests the Commission to commence the hearing scheduled for April 30, 2009, at 9:00 am due to the number of witnesses who will testify and the need to conclude the hearing on April 30 due to possible witness unavailability.

The parties will be hard-pressed to conclude the hearing in one day. At least five witnesses will be called in the hearing. Four witnesses have submitted direct testimony on behalf of Ormet; one witness on behalf of the Office of Ohio Consumers' Counsel; and there are additional intervenors who may seek to cross-examine witnesses. Additionally, some of the witnesses are unavailable on May 1, if the hearing continues into a second day.

Therefore, Ormet seeks to commence the April 30th hearing at 9:00 am (rather than the scheduled 10 a.m. time) to give the parties the best opportunity possible to conclude the hearing in one day.
