Re: Ohio Edison Company, The Cleveland Electric Illuminating Company and The Toledo Edison Company Request for Approval of Bill Formal Changes Case No. 09-357-EL-UNC

Dear Ms. Jenkins:

On April 27, 2009, Ohio Edison Company, The Cleveland Electric Illuminating Company, and The Toledo Edison Company ("Companies") filed an Application in the above referenced proceeding requesting certain modification to their bill format. On May 11, 2009 the Companies made a filing which modified certain of the proposed changes in the April 27, 2009 filing. On May 13 the Commission issued an Order in this proceeding. As a result of the Commission's decision not to phase-in any generation charges, the Companies' Rider NDU under the terms of the Companies' ESP Stipulation becomes bypassable. Therefore, the Companies will include Rider NDU in the "Bypassable Generation and Transmission Related Component" on the bill. Doing so does not change the bill format appearance or cause any changes to the language contained on the bill. Thank you.
