

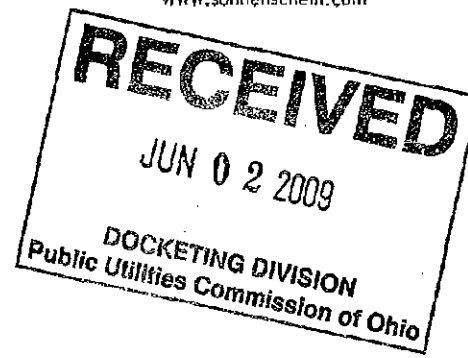

**ERRATA FOR MOTION
FOR PROTECTIVE ORDER**

Ormet Primary Aluminum Corporation ("Ormet") hereby files an Errata relating to its May 29, 2009 Motion for Protective Order.

The Motion for a Protective Order, at page 2, states the following: "The only persons with access to this [confidential] information are Ormet's Board of Directors, its senior management team, and its auditors and lenders, with whom Ormet has entered into confidentiality agreements."

It should have stated: "The only persons with access to this information are Ormet's Board of Directors, its senior management team, its lenders (with whom Ormet has entered into confidentiality agreements) and its auditors."

This change is not material to the motion. Ormet still restricts release of the confidential information and makes every effort to prevent its disclosure. It is simply not necessary for Ormet to require its auditors to enter confidentiality agreements because their use of the confidential information is controlled and restricted by professional rules governing their conduct.


