**AMENDMENT TO THE MOTION OF AT&T COMMUNICATIONS OF OHIO,
INC. AND TCG OHIO TO REVIEW DECISION OF
THE NEUSTAR POOLING ADMINISTRATOR**

On June 1, 2009, AT&T Communications of Ohio, Inc. and TCG Ohio filed a motion for the Public Utilities Commission of Ohio to review and overturn a decision made by the Neustar Pooling Administrator denying a request for numbering resources. AT&T Communications of Ohio, Inc. was inadvertently included as a joint movant in the filing. Rather, TCG Ohio is the sole telecommunications carrier who seeks the review of the Neustar decision, as TCG Ohio was the carrier who specifically requested the one thousand block of numbers for the Bedford rate center and was denied.
