- I am Manager of Arthur Mutual Telephone Company ("Arthur Mutual"), 21980
 SR 637, Defiance, Ohio 43512. I make this Affidavit on behalf of Arthur Mutual and do so in the ordinary discharge of my responsibilities.
- Arthur Mutual is a small local exchange company serving approximately 1,400 access lines in the "419" NPA.
- 3. On August 9, 2001, the Commission issued an Entry requiring each local service provider to file an affidavit in this docket attesting to the applicable dialing patterns for the completion of local calls. This affidavit is submitted in response.
- 4. Arthur Mutual provides no interNPA local calling, as local calls are defined in footnote 1 of the Commission's August 9, 2001, Entry in this case.
- 5. With respect to the overlay of the new area code in the 419 NPA, Arthur Mutual will require 10-digit dialing for intraNPA local calls upon expiration of the permissive 7- or 10-digit dialing period (December 1, 2001).
