

SECTION V - RATES

GENERAL SERVICE TARIFF SCHEDULE

Applicable:

To all general service sales volumes, except customers located in the Villages of Deshler, McComb, Hoytville, Hamler, Holgate, and Malinta.

General Sales Rate:

All Mcf per meter, per month, \$2.84029 per Mcf.

A Customer Charge of \$9.18 per meter, per month, regardless of usage.

Gas Cost Recovery:

In addition to the above rates, all gas consumed is subject to the Gas Cost Recovery (GCR) as required by Commission Orders dated October 11, 1978 and October 18, 1979 in Case No. 76-515-GA-ORD. The GCR rate of \$ 5.8505 per Mcf shall apply to all sales in the Company's central Ohio service area.

Gross Receipts Tax Rider:

The amount due on all bills shall be adjusted for the Ohio gross receipts excise tax at the rate of 4.9810%.

MCF Tax Rider:

The amount on all bills shall be adjusted for the Ohio Excise (Mcf) tax as follows:

First 100 Mcf per account per month	\$.1593 per Mcf
Next 1900 Mcf per account per month	\$.0877 per Mcf
Over 2000 Mcf per account per month	\$.0411 per Mcf
