Answer 3: Question J.3 on the initial application should have been checked "Other". The facility will be net metered as a behind-the-meter project with MetEd/FirstEnergy, the utility.

Question 4: Your application indicates that you have an account with GATS, but does not convey a GATS generation ID number. Has your facility been assigned such a number, and if so, what is it?

Answer 4: No number has been assigned yet.

Question 5: Question G, Certification Criteria 2, seeks a written description of your facility. Included in this is a description of how the facility will be measured and verified. Please provide details addressing these issues.

Answer 5: The meter will be located at the point of connection. PPL will remotely read the meter through its SCADA system.

Question 6: Your application does not provide certain information (i.e., meter specifications, meter photo, etc), presumably because your facility in not yet on-line. Please acknowledge that this required information will be provided when available consistent with the directions in the Filing Instructions.
