Dear Mr. Humphrys:

I have reviewed our Natural Heritage maps and files for the Canton Central Cloverdale/Cloverdale Torrey 138 kV Structure Relocation project area, including a one mile radius, in sections 20 and 29 of Perry Township, Stark County, and on the Massillon Quad. We have no records for rare or endangered species or other significant natural features within the project area. However, please note the location of the Tuscarawas River State Park (ODNR Division of Parks & Recreation) within the one mile radius of the project site and as shown in green on the attached map.

There are no dedicated state nature preserves or scenic rivers at the project site. We are also unaware of any unique ecological sites, geologic features, animal assemblages, state forests or state wildlife areas within a one mile radius of the project area.

Our inventory program has not completely surveyed Ohio and relies on information supplied by many individuals and organizations. Therefore, a lack of records for any particular area is not a statement that rare species or unique features are absent from that area. Please note that although we inventory all types of plant communities, we only maintain records on the highest quality areas.
