**MEMORANDUM IN SUPPORT**

---

Eastern Natural Gas Company, Pike Natural Gas Company, the Staff, the Office of the Ohio Consumers' Counsel and the Ohio Partners for Affordable Energy have met to resolve the issues in the case. The parties are now reviewing revised language in an attempt to finalize a Joint Stipulation and Recommendation to be filed in these cases.

It is unlikely that the parties will be able to reach a final agreement on language prior to the hearing scheduled for September 25 in Case No. 08-941-GA-ALT and in Case No. 08-940-GA-ALT.

A continuance of the September 25 hearing is necessary for the parties to finalize a Joint Stipulation and Recommendation. The Applicants will continue to inform the Attorney Examiner as to the status of the Joint Stipulation.

Good cause exists for granting the request for continuance of the hearing. Neither the Staff nor the Ohio Consumers' Counsel nor Ohio Partners for Affordable Energy object to this motion.

The Applicants respectfully request that the September 25 hearing be continued to a date and time to be determined.


