Comcast Phone of Ohio, LLC ("Comcast Phone") submits this application to amend its Certificate No. 90-9216 to remove reference to the fictitious name "AT&T Digital Phone" because Comcast Phone no longer uses this fictitious name, and has not for some time.

On December 4, 2002, Comcast Phone registered the name "Comcast Phone of Ohio, LLC" with the Secretary of State. See Attachment 1. On January 9, 2003, Comcast Phone registered the fictitious names "AT&T Digital Phone" and "Comcast Digital Phone" with the Secretary of State. See Attachment 2. (Comcast Phone filed a renewal of the fictitious name "Comcast Digital Phone" with the Secretary of State on December 26, 2007. See Attachment 3.)

On January 10, 2003, Comcast Phone requested that its former name, "AT&T Broadband Phone of Ohio, LLC," be changed to its current name, "Comcast Phone of Ohio, LLC d/b/a Comcast Digital Phone d/b/a AT&T Digital Phone." See Docket No. 03-139-TP-ACN. The Commission issued a revised Certificate No. 90-9216 with the new name on February 26, 2003, Docket No. 03-139-TP-ACN.

On or about January 11, 2005, Comcast Phone filed a registration update with the Secretary of State seeking to cancel the fictitious name "AT&T Digital Phone." See Attachment 4. Since at least that time, Comcast Phone has not used the fictitious name "AT&T Digital Phone" in connection with services provided in Ohio.

Recently, Comcast Phone discovered that its Certificate continued to reflect the fictitious name "AT&T Digital Phone." Accordingly, Comcast Phone submits this Application in order to correct this administrative oversight, and to maintain the accuracy of the Commission's records.

Comcast Phone states that this name change will be completely transparent to all existing and potential customers in Ohio, as the fictitious name "AT&T Digital Phone" is not being used, and has not been for some time. Comcast Phone respectfully requests that the Commission acknowledge that the name change will not affect any existing or potential customers in Ohio, and, thus, that any customer notice requirement required under the Commission's rules is not necessary in this particular case, and moreover, may actually cause more customer confusion since existing and potential customers are not aware of this fictitious name.
