

A 16-year-old male for probation violation, was ordered: 15 days detention, intensive probation, 18 hours public service, fined \$30, treatment court, and attend Lifeworks.

A 17-year-old male, for habitual disobedience, was ordered: Placed in protective supervision of Hardin County Dept. of Jobs and Family Service, standard probation, 6 hours public service, written supervision plan, and mental health evaluation.

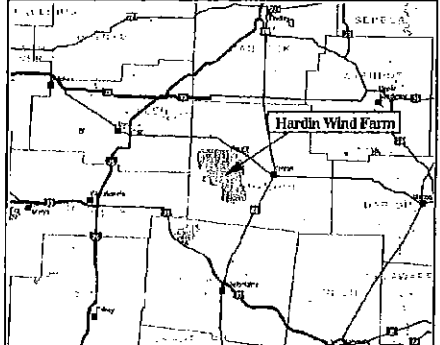

### FACILITY DESCRIPTION

Hardin Wind Energy LLC, an affiliate of Invenegy Wind Development LLC, has an amended application pending before the Ohio Power Siting Board, Case No. 09-479-EL-BGM. Its application, as amended, proposes to construct a 300 MW wind-powered electric generation facility consisting of approximately 200 1.5 MW wind turbines in the western portion of Hardin County that will spread across 23,000 acres of leased land in Hardin County. It will be located in portions of the townships of Lynn, Cessna, Maxton, Roundhead, McDonald, and Taylor Creek. The general purpose of the project is to produce clean, renewable, reliably priced, low cost electricity to the Ohio electric marketplace, and bring dozens of new jobs to Hardin County and the surrounding area.

### OHIO POWER SITING BOARD APPLICATION REVIEW CRITERIA

Pursuant to Ohio Revised Code Section 4906.10(A) the Ohio Power Siting Board shall not grant a certificate for the construction, operation, and maintenance of a major utility facility, either as proposed or as modified by the Board, unless it finds and determines all of the following: (1) The basis of the need for the facility; (2) The nature of the probable environmental impact; (3) That the facility represents the minimum adverse environmental impact, considering the state of available technology and the nature and economics of the various alternatives, and other pertinent considerations; (4) In the case of an electric transmission line, that the facility is consistent with regional plans for expansion of the electric power grid of the electric systems serving this state and interconnected utility systems and that the facility will serve the interests of electric system economy and reliability; (5) That the facility will comply with Chapters 3704, 3734, and 6111 of the Revised Code and all rules and standards adopted under those chapters and under Sections 1501.33, 1501.34, and 4561.32 of the Revised Code. In determining whether the facility will comply with all rules and standards adopted under Section 4561.32 of the Revised Code, the board shall consult with the office of aviation of the division of multi-modal planning and programs of the department of transportation under Section 4561.34 of the Revised Code; (6) That the facility will serve the public interest, convenience, and necessity; (7) In addition to the provisions contained in divisions (A)(1) to (9) of this section and rules adopted under those divisions, what its impact will be on the visibility of agricultural land of any land in an existing agricultural district established under Chapter 929 of the Revised Code that is located within the site and alternative site of the proposed major utility facility; rules adopted to evaluate impact under Division (A)(7) of this section shall not require the completion, creation, submission, or production of any information, document, or other data pertaining to land not located within the site and alternative site; and (8) That the facility incorporates maximum feasible water conservation practices as determined by the board, considering available technology and the nature and economics of the various alternatives.

### STATEMENT PURSUANT TO OHIO REVISED CODE SECTION 4906.07

Upon the receipt of an application complying with Section 4906.06 of the Revised Code, the Ohio Power Siting Board shall promptly fix a date for a public hearing thereon, not less than sixty nor more than ninety days after such receipt, and shall conclude the proceeding as expeditiously as practicable. The public hearing for this case shall consist of two parts:

- (1) A non-adjudicatory hearing, pursuant to Section 4906.08(C), Revised Code, where the Board shall accept written or oral testimony from any person on January 5, 2010, at 6:00 p.m., at the Hardin County Courthouse, Veterans Hall, One Courthouse Square, Kenton, Ohio 43226; and
- (2) An adjudicatory hearing commencing on January 12, 2010, at 10:00 a.m., at the offices of the Public Utilities Commission of Ohio, Hearing Room 11-F, 180 East Broad Street, Columbus, Ohio 43215-3793.

The chairman of the Ohio Power Siting Board shall cause each application filed with the Ohio Power Siting Board to be investigated and shall, not less than fifteen days prior to the date any application is set for hearing, submit a written report to the Ohio Power Siting Board and to the applicant. A copy of such report shall be made available to any person upon request. Such report shall set forth the nature of the investigation, and the report shall contain recommended findings with regard to division (A) of Section 4906.10 of the Revised Code and shall become part of the record and served upon all parties to the proceeding.

### STATEMENT OF OHIO REVISED CODE SECTION 4906.08(C)

The Ohio Power Siting Board shall accept written or oral testimony from any person at the public hearing, but the right to call and examine witnesses shall be reserved for parties. However, the board may adopt rules to exclude repetitive, immaterial, or irrelevant testimony.

The deadline for filing notice of intervention by a public official served with a copy of the Amended Application is within thirty (30) days of being served with a copy of the Amended Application. The Board will accept petitions to intervene in the adjudicatory hearing by interested persons up to thirty (30) days after publication of the initial public notice required by Rule 4906-5-08(C)(1), O.A.C. 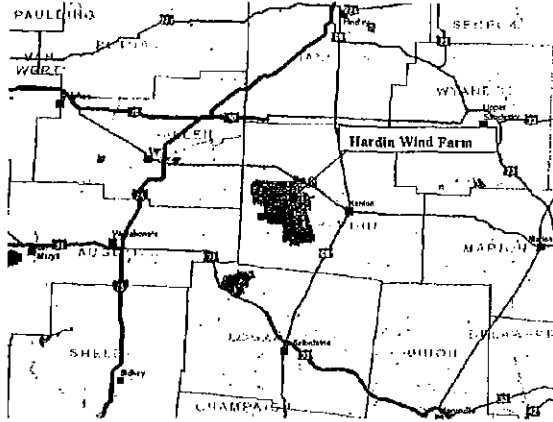
