

MEMORANDUM IN SUPPORT

Duke Energy Ohio respectfully requests that the Public Utilities Commission of Ohio, ("Commission") grant its Motion to Extend Procedural Schedule.

On August 19, 2009 an Entry was issued in which a procedural schedule was established. The remaining dates in that schedule are the following:

October 29, 2009 – In the event all of the issued raised in the comments are not resolved, or if the Commission deems the application may be unjust or unreasonable, a hearing will be held and Staff and intervenor testimony will be due on this date; November 5, 2009 – Deadline for Duke Energy Ohio to file supplemental testimony; and November 16, 2009 – hearing to commence at 10:00am.

The parties to this case are negotiating and hope to have a settlement by filing a stipulation. The parties wish to continue the procedural schedule by one week and propose that the following dates be changed to:

- November 2, 2009 Staff and Intervenor testimony due
- November 9, 2009 Duke Energy Ohio to file supplemental testimony
- November 16, 2009 hearing to commence at 10:00 a.m.
