McLeodUSA Telecommunications Services, Inc. ("McLeodUSA") and US LEC Communications Inc. ("US LEC Comm.") (collectively, "Applicants"), by their undersigned counsel, hereby submit for filing an application seeking Commission approval to change McLeodUSA's name to "McLeodUSA Telecommunications Services, LLC", and US LEC Comm.'s name to "US LEC Communications LLC", and to execute a pro forma reorganization. As discussed in the enclosed Application, McLeodUSA and US LEC Comm. intend to change their forms of business organization, by converting (as permitted under Iowa and North Carolina law) from corporations to limited liability companies. The conversions will not involve a transfer of assets nor a change in ownership or control of McLeodUSA or US LEC Comm. Indeed, the conversions will be transparent to Applicants' Ohio customers. Furthermore, Applicants request Commission approval, to the extent necessary or required, to undertake a pro forma corporate reorganization.

Applicants therefore respectfully request expedited consideration and grant of the Application as soon as possible but not later than December 31, 2009. To that end, Applicants are filing a Motion for Waiver of the thirty-day approval process set forth in Section 4901:1-6-14(B)(2) of the Ohio Administrative Code.

APPLICATION

I. <u>INTRODUCTION</u>

McLeodUSA Telecommunications Services, Inc. d/b/a PAETEC Business Services ("McLeodUSA") and US LEC Communications Inc. d/b/a PAETEC Business Services ("US LEC Comm.") (collectively, "Applicants"), by their undersigned counsel, hereby request Commission approval, to the extent necessary or required under Ohio law, to change their names from "McLeodUSA Telecommunications Services, Inc." to "McLeodUSA Telecommunications Services, LLC" and "US LEC Communications Inc." to "US LEC Communications LLC", respectively. The name change will result from converting each Applicants' business form from a corporation to a limited liability company. Following the conversion, McLeodUSA and US LEC will continue to do business in Ohio using the "PAETEC Business Services" name.

The conversions — indeed, the name changes themselves — will be transparent to Applicants' Ohio customers. Applicants therefore respectfully submit that Commission approval is

required only to the extent necessary to change their respective names to "McLeodUSA Telecommunications Services, LLC" and "US LEC Communications LLC".

II. THE APPLICANTS

A. <u>McLeodUSA Telecommunications Services</u>, <u>Inc. d/b/a PAETEC Business</u> <u>Services</u>

McLeodUSA is an Iowa corporation with principal offices located in Hiawatha, Iowa. McLeodUSA provides integrated communications services, including local services, primarily in 20 Midwest, Southwest, Northwest, and Rocky Mountain states. In Ohio, McLeodUSA is authorized to provide local and interexchange telecommunications services in Ohio pursuant to certification granted in Docket Nos. 99-972-TP-ACE and 99-983-TP-ATR.

B. <u>US LEC of Communication Inc. d/b/a PAETEC Business</u>

US LEC Comm. is a North Carolina corporation principal offices located at 6801 Morrison Boulevard, Charlotte, North Carolina 28211. US LEC Comm. provides intrastate telecommunications services in six states, including Ohio. In Ohio, US LEC Comm. is authorized to provide local and interexchange telecommunications services pursuant to authorization grant in Docket No. 90-9096.

C. PAETEC Holding Corp.

PAETEC Holding Corp. ("PAETEC Parent") is a publicly traded Delaware corporation (NASDAQ GS: PAET) with principal offices located at One PAETEC Plaza, 600 Willow Brook Office Park, Fairport, New York 14450. Through its regulated operating subsidiaries, PAETEC Parent has a presence in 83 of the nation's top 100 MSAs, delivering communications solutions to business customers in 48 states and the District of Columbia. Additional information regarding PAETEC Parent, including its most recent SEC Form 10-Q, as filed with the Securities and Exchange Commission, is available at www.paetec.com.

III. <u>DESCRIPTION OF NAME CHANGE</u>

A. The Conversion of McLeodUSA and US LEC Comm. from Corporations to Limited Liability Companies

The proposed name change will result from the conversion of McLeodUSA from an Iowa business corporation to an Iowa limited liability company, and US LEC Comm. from a North Carolina business corporation to a North Carolina limited liability company. The conversions will not involve the merger of McLeodUSA or US LEC Comm. with any other entity. Rather, the conversions will be accomplished through the filing of Articles of Organization Including Articles of Conversion, or similar documents, with the appropriate secretaries of state. The purpose of filing such articles is to form limited liability companies through the conversion of business entities. Here, the filing of Articles of Organization Including Articles of Conversion or similar documents will convert McLeodUSA and US LEC Comm. to limited liability companies by operation of law. Following the conversions, the converted McLeodUSA and US LEC Comm. entities will continue to be indirect, wholly-owned subsidiaries of PAETEC Holding.

B. The Converted Entities Will Be Recognized as the Same Entities as the Converting Entities

Under the law governing Applicants' formation and existence, when the conversion takes effect, Applicants will continue in existence as the resulting limited liability companies, with all of the assets, liabilities, interests, rights, and obligations of McLeodUSA Telecommunications

Services, Inc. and US LEC Communications Inc., respectively. Specifically, under Iowa and North Carolina law, an entity that converts to a limited liability company is recognized as the same entity. When the conversion takes effect, each converting business entity ceases its prior form of organization and continues in existence as the resulting limited liability company. All of the assets, liabilities, interests, rights, and obligations of the converting entity continue as those of the resulting limited liability company. Moreover, the cessation of the existence of each converting business entity in its prior form of organization does not constitute a dissolution or termination of the converting business entity.

Here, the assets, liabilities, interests, rights, and obligations of Applicants will remain vested in the converted entities. Applicants will simply continue in existence in the form of limited liability companies. Because the converted entities will be recognized as the same entities as the converting entities, and no transfer of assets or liabilities will have occurred, Applicants respectfully submit that regulatory approval is required only to extent necessary to change their respective names from "McLeodUSA Telecommunications Services, Inc." to "McLeodUSA Telecommunications Services, Inc." to "McLeodUSA Telecommunications Services, Inc." to US LEC Communications LLC".

C. Applicants Will Make the Necessary Filings to Reflect the Name Change, Which Will be Transparent to the Applicants' Customers

The converted McLeodUSA limited liability company and US LEC limited liability company, which, as discussed above, are the same entities as the original pre-transaction corporations, will also file with the Commission a tariff adoption supplement to adopt as their own the tariffs of McLeodUSA Telecommunications Services, Inc. and US LEC Communications Inc., respectively. Given that each company's name change will simply reflect the conversion from an incorporated company to a limited liability company (*i.e.*, only the corporate form designation will change – from "Inc." to "LLC" – and the rest of the name will remain the same), the name changes will be transparent to the Applicants' Ohio customers in terms of the services the customers receive.

As required, the Applicants will file with the Ohio Secretary of State a Registration of a Foreign Limited Liability Company form reflecting the corporate form conversion and the resulting name change. Attached to this Application as Exhibit A are copies of the form for illustrative purposes only. The Applicants have not yet filed these forms with the Ohio Secretary of State, but are in the process of doing so. The information provided on the Registration of a Foreign Limited Liability Company forms that the Applicants ultimately file may differ from the forms attached hereto. Upon receiving certifications of the limited liability company registrations from the Ohio Secretary of State, the Applicants will submit copies of the certifications to the Commission in connection with this Application.

IV. <u>CONCLUSION</u>

WHEREFORE, McLeodUSA Telecommunications Services, Inc. and US LEC Communications Inc. respectfully request Commission approval of the name changes described herein, and grant of all such other relief as may necessary or appropriate to permit it to continue to provide telecommunications services to its Ohio customers. The Applicants request that the

Commission approve these transactions as soon possible, but not later than <u>December 31</u>, 2009, as the pro forma reorganization and corporate form conversions are set to occur by that date. In requesting an expedited review by the Commission, the Applicants are submitting a Motion for Waiver of the thirty-day approval process set forth in Section 4901:1-6-14(B)(2) of the Ohio Administrative Code.
