Dear Ms. Jenkins:

On November 12, 2009, Columbus Southern Power Company and Ohio Power Company (collectively, "AEP Ohio") filed a Stipulation and Recommendation in the above-caption cases, along with several Signatory Parties.

In Paragraph V.2. of the Stipulation, AEP Ohio agreed to file in November 2009 an incentive-based REC program for solar photovoltaic and small wind resources to encourage residential and non-residential customers to install renewable energy resource facilities on the customer premises, subject to Commission approval of design and cost recovery. On November 30, 2009, AEP Ohio initiated Case Nos. 09-1871-EL-ACP and 09-1872-EL-ACP in fulfillment of this Stipulation commitment.

Separately, in Paragraph V.3. of the Stipulation, AEP Ohio agreed to file in November 2009 a solar photovoltaic and small wind REC purchase program for residential and non-residential customers with existing renewable energy resource facilities effective for 2010-2011, subject to Commission approval of design and cost recovery. On November 30, 2009, AEP Ohio initiated Case Nos. 09-1873-EL-ACP and 09-1874-EL-ACP in fulfillment of this Stipulation commitment.
