Dear Ms. Jenkins:

On November 12, 2009, Columbus Southern Power Company and Ohio Power Company (collectively, "AEP Ohio") filed a Stipulation and Recommendation (Stipulation) in the above-caption cases, along with several Signatory Parties. Since that time, Ormet Primary Aluminum Corporation (Ormet) sought to intervene in these cases and AEP Ohio subsequently inquired as to Ormet's position on the Stipulation. Ormet has indicated its support for the Stipulation and expressed interest in signing on as a Signatory Party. 
