

**AMENDED COMPLAINT INSTANTER**

Now comes Complainant, Forest Hills Supermarket, Inc. dba Konnis Family Foods, ("Forest Hills") by and through counsel, and hereby respectfully moves this Commission for leave to file a First Amended Complaint *Instanter*. The basis for this motion is to amend the Complaint to include all damages suffered by Complainant as a direct and proximate result of Cleveland Electric Illuminating Company shutting off power to Forest Hills. Additional damages came to light during our most recent settlement conference on November 18, 2009. Accordingly, Complainant is amending its Complaint to include all damages to insure it is made whole. This motion is not meant to delay the proceedings and will not prejudice any party to this action. Therefore, Complainant request that it be granted leave of this Commission to file its First Amended Complaint. A proposed order is attached for this Commission's convenience.

Now comes Complainant, Forest Hills Supermarket, Inc., dba Konnis Family Foods, ("Forest Hills") by and through undersigned counsel and states the following for its Amended Complaint against Cleveland Electric Illuminating Company:

1. Forest Hills is a corporation licensed to conduct business in the State of Ohio.
2. Forest Hills operates a supermarket business located at 13598 Euclid Avenue, Cleveland Ohio 44112.
3. Cleveland Electric Illuminating Company is a duly licensed public utility company in the State of Ohio as defined by Ohio Revised Code §4905.02 and §4905.03.
4. Forest Hills is filing a Complaint on Service against Cleveland Electric Illuminating Company pursuant to Ohio Revised Code §4905.22 and §4905.26 under the jurisdiction of the Public Utilities Commission of Ohio ("PUCO").
5. On or about September 14, 2008, neighboring properties around Forest Hills lost power due to a storm or other unknown cause.
6. On or about September 14, 2008 Forest Hills power was unaffected by the storm or other unknown cause and Forest Hills continued to operate its business as usual.

7. On or about September 15, 2008 Cleveland Electric Illuminating Company shut off power to Forest Hills without any notice or warning to Forest Hills.

8. Cleveland Electric Illuminating Company did not restore power to Forest Hills until sometime in the evening of September 16, 2008.

9. As a direct and proximate result of Cleveland Electric Illuminating Company shutting power off to Forest Hills, Forest Hills suffered a loss to its inventory of frozen foods, produce, meats and other perishable goods in the amount of \$103,520.96.

10. As a direct and proximate result of Cleveland Electric Illuminating Company shutting power off to Forest Hills, Forest Hills suffered damages for loss of business, unnecessary payment of wages, and costs incurred in an attempt to purchase an emergency generator, the amount of which will be better determined at trial.

11. Forest Hills attempted to resolve this issue with Cleveland Electric Illuminating Company by filing a claim with its claims department on or about October, 2008.


12. Upon information and belief Cleveland Electric Illuminating Company did settle claims with other utility customers resulting from the September 14, 2008 power outage, but refused to settle Forest Hills' claim.

13. Forest Hills seeks relief under the jurisdiction of the Public Utilities Commission of Ohio for its loss pursuant to Ohio Revised Code §4905.22 and §4905.26.

14. Forest Hills seeks treble damages under the jurisdiction of the Public Utilities Commission of Ohio for its loss pursuant to Ohio Revised Code §4905.61.

WHEREFORE, Forest Hills respectfully requests that the Public Utilities Commission of Ohio enter judgment against Cleveland Electric Illuminating Company in the amount of \$103,520.96 plus damages for loss of business, increased wages and attempted purchase of emergency generator which value will be better determined at trial, and treble damages as allowed by law.


