2. Where the word "incident" is used, it refers to the September 14, 2008 through September 20, 2008 power outage.
3. Where an Interrogatory calls for an answer in more than one part, each part should be separated in the answer so that the answer is clearly understandable.
4. You are reminded that all answers must be made separately and fully and that an incomplete or evasive answer is a failure to answer.

5. You are under a continuing duty seasonably to supplement your responses with respect to any question directly addressed to the identity and locations of persons having knowledge of discoverable matters.




