DESCRIPTION OF PROPOSAL

Vectren Energy Delivery of Ohio, Inc. ("VEDO") proposes to change the term "Customer Charge" in its residential tariffs for Rates 310 and 315, to "Delivery Charge." In its order in VEDO's most recent rate case, Case No. 07-1080-GA-AIR, the Commission approved a two stage transition to a full SFV fixed monthly charge for distribution service to residential customers. Subsequent to Commission approval on January 7, 2009 of VEDO's tariffs in that case and during discussions with Staff, it was determined that a change to the term "Customer Charge" for Stage 2 of the implementation of Rates 310 and 315 at the full SFV fixed charge would avoid customer confusion related to the transition from the traditional rate design to a fixed monthly charge for delivery of gas. Accordingly, VEDO requests to change the term "Customer Charge" in its residential tariffs for Rates 310 and 315, to "Delivery Charge" to be effective with Stage 2 implementation on February 22, 2010.

In its Opinion and Order in VEDO's last rate case, Case No. 07-1080-GA-AIR, the Commission ordered a two-stage transition to an SFV fixed monthly charge for gas delivery for residential customers, Stage 2 of which becomes effective on February 22, 2010. As originally approved, VEDO tariffs for residential Rates 310 and 315 employed the term "Customer Charge" for the fixed monthly charge. Following discussions with Staff, it was determined that the term "Customer Charge" in Stage 2 Rates 310 and 315 should be changed in order to avoid customer confusion related to the transition from the traditional rate design to the fixed monthly charge for delivery of gas. Consistent with that discussion, VEDO requests authority to change the term "Customer Charge" in its residential tariffs for Rates 310 and 315, to "Delivery Charge" to be effective with Stage 2 implementation on February 22, 2010.
