Following discussions with the Commission Staff, and under authority of Special Permission No. 09-032 of the FCC, Verizon is withdrawing revisions originally filed under Transmittal No. 1058 prior to them becoming effective on December 26, 2009, and reinstating the regulations that are presently in effect. Transmittal No. 1058 was filed on December 11, 2009, to revise regulations for the discontinuance of access service.
